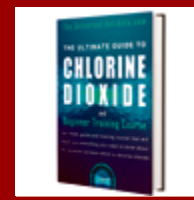

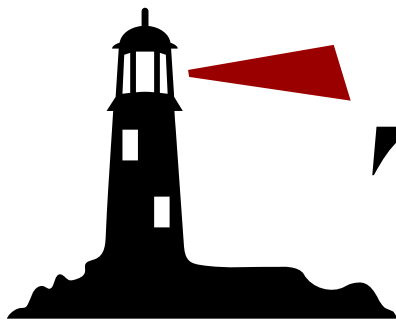

# A free country?

## Parliament now a rubber stamp for totalitarian agenda

# Attack on free speech and privacy

## Bringing in mass censorship under guise of safety

**THE House of Commons recently passed the Online Safety Bill, which represents the country's latest and most damaging attack against online free speech and privacy.**

The bill supposedly aims to keep websites and different types of internet-based platforms free of illegal and harmful material, while allegedly defending online freedom of expression at the same time.

The bill's provisions apply to search engines, internet services that host user-generated content like YouTube and social media platforms, online forums, certain kinds of online games, and sites that publish or display pornographic or otherwise adult content.

"Today, this government is taking an enormous step forward in our mission to make the UK the safest place in the world to be online," claimed Secretary of State for Science, Innovation and Technology Michelle Donelan who called the bill a



The British government, led by the Conservative Party, claimed earlier this month, in an apparent concession to the concerns of privacy activists, that the Office of Communications (Ofcom) – which will be put in charge of implementing the provisions of the Online Safety Bill – will only require messaging platforms to scan content where 'technically feasible'.

Secretary Donelan then added that further work will be done after the Bill's implementation to develop the proper technology to prevent the spread of child sexual abuse material without infringing upon personal privacy.

Dan Frieth, writing for *Reclaim The Net*, warned that the Online Safety Bill shrouds itself 'in a veil of safetyism' and only pretends to support privacy and free speech rights.

'The bill goes beyond forcing platforms to remove illegal content: it calls upon social media giants to act as custodians, safeguarding users against ill-intent messages, cyberbullying and explicit material,' Frieth wrote. 'We cannot cower from highlighting the bill's overt undertone of censorship, veering into a territory where freedom of speech and privacy might be sacrificed at the altar of digital safety.'

'From a free speech and anti-censorship perspective, this legislation is fundamentally disturbing. This bill could enhance potential censorship on the pretext of safety.'

Frieth, like many others, is concerned about the ways in which the government will roll out approved software to scan through user content to identify possibly illegal materials.

Everything from messages, photos and basically any other kind of file that users post online could be subjected to scans, and non-compliance with the scans will result in severe penalties, including criminal charges.

'The backdoor scanning system poses significant threats. It may be exploited by those with malicious intent, mishandled which could lead to false positives, resulting in unwarranted accusations of child abuse,' warned Frieth. 'These alarming flaws render the Online Safety Bill incompatible with end-to-end encryption – a staple for ensuring user privacy and security – and human rights.'

'game-changing' piece of legislation.

Once the bill receives royal assent from King Charles III, it formally becomes law, and social media platforms will be expected to remove illegal content from the internet quickly or prevent it from appearing in the first place.

These same tech companies will also be expected to prevent children from being able to access harmful and age-inappropriate content by enforcing age limits and age-checking measures.

Companies that do not comply will be issued fines of up to £18m or 10 per cent of their annual turnover.

Versions of the Online Safety Bill had been circulating in the British government for at least four years before it was finally approved by the House of Commons. Everyone from free-speech activists to Big Tech companies raised concerns about the dangers of passing this bill.

Meta, the parent company of Facebook and the messaging platform WhatsApp, warned that a provision in the law could force messaging platforms to break end-to-end encryption, which protects the contents of messages sent on their platforms.

Information security and cryptography researchers have also previously come together opposing the bill, raising concerns about how provisions to prevent the spread of child sexual abuse material will interact with security and privacy.

# Tax revolts then and now

## ‘Paying council tax unlawful as funds war crimes’

**Council Tax protestor Chris Coverdale is interviewed by Richard House**

**Richard House [RH]: “The only successful revolts in human history have been underpinned by tax revolts,” you’ve said. Tell us some of the history.**

**Chris Coverdale [CC]:** Tax rebellion, the refusal of the people to pay taxes, has been the single most effective action ordinary people can take to stop tyrannical governments, repeal unfair or unjust legislation, or persuade parliaments to enact laws benefiting the people rather than corporations, banks or warmongers.

In 1215, England’s barons refused to pay for King John’s war in Aquitaine until he had agreed to their 63 demands. Because he needed money and troops, he bowed to all their demands.

This signed-and-sealed agreement, introducing 63 new laws within a week, later became known as Magna Carta, and formed the foundation of law in England and Wales as well as in the USA, Canada, Australia and most Commonwealth countries.

In addition to Magna Carta, the stamp- and tea-tax rebellions initiated American independence, the ship tax began the English revolution in the 1640s, the bread tax in Paris, and the land taxes in Russia started the French and Russian revolutions respectively, and the salt-tax rebellion led to Indian and Pakistani independence.

In Britain, the Glasgow women’s rent strike in 1915 was initiated by 20,000 women determined to halt the evictions of soldiers’ wives and families. By gaining the support of Clyde shipyard

workers, the so-called ‘Mrs Barbour’s army’ caused the government to enact a new Housing Act, halting the evictions and rent increases.

It was only in the 1980s that Prime Minister Margaret Thatcher was able to reassert the dominance of heartless profit-seeking landlords by repealing the last vestiges of the 1915 legislation. However, ordinary taxpayers got their revenge in 1989 by initiating the Poll Tax rebellion, eventually forcing the Cabinet to sack Thatcher from her job.

**RH: When did you first realise that a tax revolt could work today?**

**CC:** The idea that I had a lawful duty to engage in tax revolt came in 2003 whilst I was reading Article 25 of the Rome Statute of the International Criminal Court: *In accordance with this Statute, a person shall be criminally responsible and liable for punishment for a crime within the jurisdiction of the Court [war crimes, crimes against humanity*

*or genocide] if that person:*

- (a) *Commits such a crime, whether as an individual, jointly with another or through another person, regardless of whether that other person is criminally responsible;*
- (b) *Orders, solicits or induces the commission of such a crime which in fact occurs or is attempted;*
- (c) *For the purpose of facilitating the commission of such a crime, aids, abets or otherwise assists in its commission or its attempted commission, including providing the means for its commission; ...*
- (f) *However, a person who abandons the effort to commit the crime or otherwise prevents the completion of the crime shall not be liable for punishment under this Statute for the attempt to commit that crime if that person completely and voluntarily gave up the criminal purpose.*

This wording made it quite clear that as a taxpayer, I’d commit an offence of aiding and abetting war crimes, crimes against humanity and genocide if I continued to pay money (tax) to the government, which they’d then use to buy and use bombs and cruise missiles to attack and injure or kill people in Afghanistan and Iraq.

The wording in 25(f) also made it clear that I, and every UK taxpayer, would have to completely and voluntarily stop paying tax if we were to avoid prosecution and punishment.

**RH: So what did you do after having this realisation?**

**CC:** I stopped paying tax in 2003. However, I didn’t realise just how corrupt our government and law enforcement authorities are. So despite this law and its UK version (s.52 of the International Criminal Court Act 2001) being crystal clear, I couldn’t find a single MP, police officer, crown prosecutor, judge or council officer willing to obey, uphold or enforce what I now

understand are the world’s most important laws.

**RH: So ‘the law’ came after you?**

**CC:** Yes. Having suffered three unlawful spells in prison, in 2017 I adopted a different approach. Instead of refusing to pay tax because it was a criminal offence to pay it, I settled all tax demands by paying the money into a conditional revocable trust for the benefit of my local council and HMRC.

**RH: How does that work?**

**CC:** The trust deed specified that the council and HMRC could have my money (tax) if, by the end of the financial year, the trustee received incontrovertible proof that the conditions in the trust deed had been met, and Britain’s involvement in all wars, and all illegal uses of armed force, had stopped, criminal proceedings had begun against 1,000s of the UK leaders responsible for starting or supporting the wars in Afghanistan, Iraq, Libya, Syria, the Yemen, Palestine and the Ukraine, and Britain was operating in full accord with the UN Charter and all 42 principles in the UN Declaration on Principles of International Law.

**RH: And the result?**

**CC:** This approach of settling taxes in conditional revocable trusts seems to be working. As more and more people join what’s best described as a civil obedience campaign, the chances of our lawful tax rebellion succeeding and spreading nationally and internationally grow exponentially.

# Two wings on the same bird

## Enacting tyranny equally from left and right of politics

**THE role of party politics - and ideological distinctions between left and right - has become problematic across the world.**

There has been a clear sense for many that the Great Reset - and the rhetoric accompanying it - originates, not from Westminster but from a technocratic/ billionaire elite class.

It is a class that operates through remote, democratically unaccountable institutions like the World Economic Forum, the World Health Organisation, the Center for Disease Control and the United Nations.

Those who have long been aware of this historical influence i.e., Jim Marrs, Patrick M. Wood, and Anthony C. Sutton, have been warning for decades that party politics is a distraction, democracy an illusion, and that real political power resides in a far more covert and nefarious location.

Whilst the influence, organisation, and principal players behind the so-called 'deep state' remain shrouded in mystery to a certain extent, an identifiable agenda has emerged since March 2020 which is clearly distinct from conventional left/right debates.

It has been argued that this is an agenda that has been orchestrated and coordinated by a small, unelected group of people who have anything but our best interests at heart.

Historians argue that the ideological evolution of the left and right political dichotomy evidences both democracy and the principles on which modern governance is based.

In the UK, the Labour Party established its early credentials through the representation of class-based interests, collective solidarity, and a push for more even distribution of income and wealth.

Traditionally, the Labour left has viewed politics and the political realm in a progressive way, in the sense that its primary modus operandi should be to act as a vehicle through which to ensure social mobility, greater economic equality, free healthcare and education, and state support for the unemployed and long-term sick.

Up until the 1980s, and particularly within the political nexus of the 'command-and-control' economies of the West, the Labour Party symbolised grassroots activism and civil society involvement in formal

politics via trade unions and working class collectives.

The identity of the Labour left was also forged out of the interplay and tension with its mirror opposite, where political right (embodied particularly in the Conservative Party) has generally favoured minimal

state regulation and the free play of market forces, preferring to let the invisible hand of economic innovation and entrepreneurship facilitate the trickle down of wealth through the class structure.

In the 1970s, the political scientist Anthony C. Sutton wrote a trilogy of books questioning the divide between left and right that the majority of historians and political commentators have assumed.

As Sutton argues, ultimately both the extreme right and the extreme left favour collectivism, big government, and a high level of state control. Documenting the secret Wall Street bankrolling of leftist movements in a series of key historical events was, according to Sutton, the long-term cultivation and planning of what he

termed 'corporate socialism'.

In *Wall Street and the Bolshevik Revolution*, *Wall Street and the FDR*, and *Wall Street and the Rise of Hitler*, Sutton outlines in detail an 'alternative view of history', which suggests that the accepted historical polarity between the left and the right

an indication of this in his 1970 book *Between Two Ages: America's Role in the Technotronic Era*, where he argued that Marxism, communism and socialism were never historical end points, but necessary stepping-stones to the New World Order that was, even then, being planned and put into motion.

So how do these insights relate to what is happening now? There is certainly an argument to suggest that the social-justice agenda of the left has been promoted and deployed by the same group of people involved with overseeing the Great Reset agenda.

It is inarguable, in fact, that left-wing politics has been an enormous presence over the last three years of government policy throughout the world. Much of the rhetoric and language Klaus Schwab and his colleagues have been using is clearly grounded in the promise of social justice, along a range of different issues.

For example, supporters of the Great Reset argue that their vision of the future will solve the environmental crisis by 'decoupling' the economy from natural fuel-based growth.

They also promise technocratic governance led by the WHO, which will ensure the containment of current and future health issues in a way that national governments have proven themselves to be incapable of. Race, gender and self-identity will also be 'democratised', and freed from modernist limitations, categorisations, and injustices.

As the looming prospect of a one-state party draws ever nearer, the societal transformations that we have seen over the last few years suggest that the days of using controlled opposition may now be fast drawing to a close.

Rapid advances and mass rollout in Smart City technology, mass surveillance systems, join-up and activation of the Internet of Things, 5G rollout, the total tie-up of the media, and the massive censorship of all opposing groups, viewpoints, and positions means that the possibilities for political, economic and social control are now well beyond anything we have seen in history.

Political manipulation, and control of opposition parties and ideologies, may no longer be necessary in a world where technology is now mature enough to take the hard yards away from the authoritarian dream, to a place where there is no longer the need for any form of delegation beyond the realms of Big Tech and its overlords.

# UN declares intent to lock us down

## Proposed powers to close schools, inject and censor

**THE United Nations General Assembly president has approved the non-binding UN declaration on Pandemic Prevention, Preparedness and Response (PPPR) - without a full assembly vote, and over the objections of 11 nations.**

Critics called the declaration - which seeks to create a global pandemic authority with the power to enforce lockdowns, universal vaccination and censorship of 'misinformation' - 'hypocrisy' and 'unhinged'.

For supporters, the declaration is a key step towards international coordination in pandemic prevention and public health.

According to the World Health Organisation, it 'presents an opportunity... to prevent and prepare for pandemics and their consequences, using an approach that involves all government sectors.'

The WHO also said the PPPR aims to 'apply lessons learned from the covid-19 pandemic' and 'comes as the world faces multiple humanitarian and climate-related crises which are threatening lives and livelihoods around the world.'

In a statement, WHO Director-General Tedros Adhanom Ghebreyesus said: 'If covid-19 taught us nothing else, it's that when health is at risk, everything is at risk.'

He linked the PPPR to the UN's Sustainable Development Goals (SDGs), saying world leaders should 'show they have learned the painful lessons of the pandemic.'

Other experts took a different view. Author and podcaster Frank Gaffney, founder and president of the Center for Security Policy, told *The Defender* website it is 'very worrying' that the UN and WHO 'will further encourage, if not actually authorise, the kind of standing capability or authority on their part to essentially dictate what constitutes emergencies.'

'There's no getting around the fact that it's going to come at the expense of the sovereignty of the various

nations that will subsequently be told that they have an emergency and told what they have to do about it,' he added. 'This is unprecedented.'

Writing for the Brownstone Institute, Dr David Bell, a public health physician and biotech consultant said a 'silence procedure' is in place in regard

to the pandemic treaty, 'meaning that States not responding will be deemed supporters of the text.' He said the text is 'clearly contradictory, sometimes fallacious, and often quite meaningless,' and intended to centralise the WHO's power.

The final text of the PPPR political declaration, dated September 1, includes statements and proposals covering a range of issues, from vaccination to so-called 'misinformation'.

Stating that 'health is a precondition for all' and an indicator of 'sustainable development,' the declaration calls for:

- **Universal vaccination:** The declaration expresses 'deep concern' about declining vaccination rates, and includes a commitment supporting 'research and development of vaccines and medicines, as well as preventive measures and treatments for communicable and non-communicable diseases.'

'Routine immunisation is one of the most efficient and cost-effective public health interventions with the greatest reach and demonstrated health outcomes,' the declaration states, while highlighting the 'important role played by the private sector in research and development of innovative medicines' including vaccines.

The treaty also calls for:

- **Making 'temporary' covid-19 powers permanent:** The declaration expresses 'concern with the continued emergence and re-

emergence of epidemic-prone diseases,' stating 'the need... to build on the lessons learned and best practices from the pandemic.'

- **Increased surveillance and digital health documents,** such as vaccine passports. The declaration recognises... the potential of

digital health technologies in 'implementing and supporting health measures and bolstering national response efforts' to pandemics and health emergencies.

- **Potential social media censorship:** The declaration expresses 'concern that health-related misinformation and disinformation negatively impacted routine immunisation services.'

Accordingly, the declaration calls for 'measures to counter and address the negative impacts of health-related misinformation, disinformation, hate speech and stigmatisation, especially on social media platforms... including countering vaccine hesitancy... and to foster trust in public health systems and authorities.'

According to Dr Bell: 'The WHO noted in 2019 that pandemics are rare, and insignificant in terms of overall mortality over the last century' but 'the WHO and the entire UN system now consider pandemics an existential and imminent threat.'

He said this is important, because: 'They are asking for far more money than is spent on any other international health program,' which will 'deliver great wealth to some people' and great powers for governments, which can be used to reimpose the very responses that have just caused the largest growth in poverty and illness in our lifetimes.'

Bell said that while the declaration pays lip service to issues such as women's rights and education, it contradicts itself by supporting covid-19-style restrictions, including 'closing schools

and disproportionately throwing women out of work and into poverty'.

But consensus on the PPPR is not at all universal. In a letter to Dennis Francis, president of the United Nations General Assembly, co-signed by the representatives of 11 countries, 'legitimate concerns' were being ignored.

The 11 countries are Belarus, Bolivia, Cuba, the Democratic People's Republic of Korea, Eritrea, the Islamic Republic of Iran, Nicaragua, the Russian Federation, the Syrian Arab Republic, Venezuela and Zimbabwe.

Their letter broke the 'silence procedure', stating: 'Our delegations are convinced that this is no way to handle multilateral and intergovernmental negotiations on issues of great relevance for the international community, particularly for developing countries.'

It added that 'no consensus has been reached on any of these processes.' However, the letter does not contain specific objections to the content of the PPPR declaration.

In addition to national representatives, organisations like Gavi, the Vaccine Alliance - recognised as a stakeholder and 'observer' by the WHO - also participated in the debate.

Gavi states it 'helps vaccinate almost half the world's children against deadly and debilitating infectious diseases'.

The Bill & Melinda Gates Foundation is a partner of Gavi and holds a permanent seat on its board - as do the WHO, UNICEF and the World Bank.

Gavi described this year's UNGA as 'a sobering milestone' on the path towards meeting the 2030 target date for the SDGs, and said the high-level meeting is 'a one-time and historic opportunity for leaders to adopt a whole-of-government, whole-of-society, global approach to addressing pandemic threats.'

Dr Bell said that Gavi is an example of an organisation that was not 'negatively impacted' by the covid-19 catastrophe. 'People and corporations who sponsor much of the WHO's health emergency work, and that of its sister organisations such as CEPI, Gavi, and Unitaid, did very well from the policies they advocated so strongly for,' he wrote.

# Challenge childhood injections

## Self-perpetuating vaccine industry based on fear

**THE number of vaccines given to babies and children has increased dramatically without the necessary due diligence by regulatory authorities.**

In response, parents are now being urged to adopt a common-sense 'Safer to Wait' approach.

Growing international concerns about vaccine regulatory processes and vaccine safety have emerged following the widespread regulatory failure of covid-19 vaccines. The covid-19 crisis has demonstrated that regulatory bodies - once public watchdogs - are now, at best, incompetent and, at worst, have been deeply corrupted by pharmaceutical industry interests.

In the context of emerging revelations of regulatory body incompetence and corruption, such as in the The Perseus Report, the World Council for Health's health and science committee noted:

- Several research studies now indicate that vaccinated children have far worse health outcomes with higher rates of many chronic diseases than non-vaccinated children.
- The integrity of scientific research and the regulatory process of childhood vaccines, including the new nasal flu vaccine now being administered en masse in schools, is in question.
- Pharmaceutical corporations have a long-standing history of misrepresenting products that

cause injuries and deaths. Pfizer, for instance, has paid the largest criminal settlement in history for drug fraud. The childhood vaccination schedule provides these unscrupulous corporations with unregulated access to the bodies of our children.

- Modern society is experiencing unprecedented rates of autism, asthma, allergies, inflammatory bowel disease, diabetes, obesity, depression and more, for which the root causes have not been established.
- Much of what we have been told about the success of early vaccines, including smallpox and polio vaccines is emerging as untrue. Clean water, modern plumbing, hygiene, refrigeration, and improved nutrition are real factors that have correlated with the dramatic reduction in many diseases over the past century.
- National regulatory agencies have never done the necessary evaluation to determine whether vaccines given to children alone or together, according to the ever-expanding childhood vaccination schedules, are associated with poor health outcomes, compared with children who are not vaccinated.
- National regulatory agencies have been turning a blind eye to the mounting evidence linking childhood vaccination with autism that has emerged since a possible link was first suggested in 1998.
- National regulatory agencies have also been turning a blind eye to the mounting evidence linking childhood vaccination with other diseases, including asthma, allergies, bowel disease.
- The vast majority of children find vaccination with needles painful, and long-term psychological harms, including disruption to breastfeeding and maternal bonding, have not been properly evaluated.
- There are serious concerns among experts that existing childhood vaccines will be converted to mRNA technology, which has never been proven safe for use in vaccines for adults, let alone children, and that this will be done without public awareness, consent and a robust research and regulatory process.
- Evidence from independent experts and official international databases shows that the covid-19 vaccines are not effective and are not safe, raising serious questions around the authorisation of the vaccines for babies and children.

In addition to these specific considerations, the burgeoning vaccination schedule for children needs to be viewed in the context of the following supranational developments in global health policy:

- The World Health Organisation (WHO) and its private and state stakeholders have financial and ideological interests in the

provision of vaccines, and have committed to providing 500 vaccines by 2030.

- The WHO and its stakeholders are working for the pharmaceutical industry, and creating a treaty that would give them the power to mandate injections by force for you and your children.
- The WHO supports gain-of-function research, facilitating the creation of dangerous pathogens as well as the vaccines, to combat newly-created pathogens, thus creating a self-perpetuating vaccine industry based on fear.

In the current circumstances, the World Council for Health urges parents to consider childhood vaccination very carefully and adopt a common-sense 'Safer to Wait' approach to the vaccination of your boys and girls.

Don't fall for the vaccine fear-mongering and guilt-provoking propaganda.

For the sake of all children and a healthy society, it is time that we question our blind faith in vaccines, the corporations that produce them, and the regulatory bodies and supranational organisations that enable and profit directly or indirectly through their authorisation.

Reducing infectious disease and maximising your children's health is rooted in wholesome nutrition, good physical and mental hygiene, a healthy outdoor lifestyle and your unconditional love.

# I survived Liverpool Care Pathway

## Patient cheated death after being put on killer protocol

**“I HAD Crohn’s disease and was in hospital with a ruptured oesophagus. I was being fed through tubes but they left the tubes in too long and I got sepsis. That’s when they put me on the death pathway. I was on it for six days. It destroyed my kidneys. I suffered full organ failure - I have this written in my medical records.**

Doctors obviously decided I wasn’t dying fast enough so they ordered that I stayed on the pathway for another six days.

I was fighting for my life, fighting to survive. I was hallucinating badly - really terrifying visions - and I was so thirsty. I believed I was in the jungle, searching

desperately for water. At one point, using all my energy, I shouted out ‘get me a drink now!’ If I hadn’t have shouted, I would be dead now. I wouldn’t have lasted another day.

Amazingly, I’m still alive. I’m still unwell - I was diagnosed with thyroid cancer three years ago - but I am living proof the doctors get it wrong. I survived, so it’s obvious that others put on that pathway would have survived too.

The Liverpool Care Pathway (LCP) was barbaric and I was glad to hear it had been abolished in 2014. But from what I’m hearing now, it never went away. It was renamed NG163 in 2020, and innocent people who aren’t at the end of their lives are being killed using this guideline.

I’m hoping that by telling my story, I can raise awareness of what’s going on in UK hospitals, and pray that people will look out for their family members who have to go into hospital.

By the way, I’m not elderly. I am 51 now and

was 38 when I was put on the LCP.

Keep a close watch on the doctors and nurses. They’re not all good. I don’t want to tar them all with the same brush; some are really kind and would fight for their patients, but others would kill you without a second thought.

An evil person is never good to be around when you’re ill and vulnerable. Your life is in their hands and that’s scary. They can - and will - make you die slowly and painfully, whilst telling your family and friends they are doing it to be kind.

Many are ‘just following orders’; others are making the orders. They all need to be held accountable.”

# Stars align for the new world order

## Flags being used to reinforce ‘divine right’ to rule

**OVER four billion of the world’s people are living under stars.**

I don’t mean the distant suns of outer space which flicker in the night sky, but the symbolic depiction on national flags.

Why is this pointed shape so ubiquitous, and what is its significance?

Remainers plead to their friends in Europe: ‘Hold our star for us’.

They are still wishing on the star that represented Britain’s membership of the EU. The celestial circle has grown with expansion of the federalist bloc, but had its first reverse when the UK finally left in 2020, four years after the vote for Brexit.

With our iconic union flag, and the crosses of constituent nations (as well as the Welsh dragon), we have never had stars as a national symbol.

At the Last Night of the Proms, the BBC gave prominence to the EU fanatics in the crowd - who politicise this annual patriotic celebration - by flying the flag of the Brussels-based superstate.

If the EU flag seems alien to our culture, it is also overriding the distinct heritage of our continental neighbours whose flags are striped rather than astral (Germany, Spain, Belgium, Netherlands, Italy, France, Austria) or with Christo-pagan crosses (Scandinavia). I’m no vexillologist (someone who studies



the history and symbolism of flags) but clearly the star is a pervasive symbol in national and supernational insignia.

The five-pointed star is the standard depiction on flags or symbols of merit, but there are variations on the theme. The easiest way to draw a star is with two equilateral triangles, one pointing upwards and the other downwards, partially overlapping each other. Hey presto – a Star of David. Another example is the seven-pointed Australian display of the Southern Cross constellation.

Elsewhere, five-pointed stars are the rule: the EU, numerous African and Middle East countries, and the Stars and Stripes with a star for each state (emphasising

constitutional autonomy).

Despite being sworn adversaries of the USA, the communist regimes of China and other Far East revolutionary states also used the five-pointed star.

In the 1920s, Leon Trotsky chose this as the symbol for international communism. He was inspired by the Jewish mystical teachings of Kabbalah, with its iconic pentagram in the middle of a Star of David.

The U.S. military establishment in Washington is another five-edged shape: The Pentagon. What is the significance of this phenomenon?

The late Maltese psychologist Edward de Bono, in *I am Right – You are Wrong* (1990)

observed: ‘If, in the scene we are confronting, there is something we recognise, we may ignore the rest and follow only that pattern.’

According to De Bono, symbolic associations are wired into neural circuitry. Have we been trained to see the state as a source of brightness, and, thus, power?

The star is rooted in the principle of monarchy as spiritually-empowered rule, signifying the divine rights of kings.

Today, it is impersonalised as the state but, as in the past, it conveys a message of unquestionable authority.

The EU flag is a grand deception, suggesting sovereign states in fraternity. As the United States of Europe is controlled from the centre, there should be a large star in the middle of the flag. Perhaps a more apt presentation would be a black hole, sucking the nation states into an abyss, depriving them of light? Whether their people know it or not, the civic democracies of Europe are being sucked into a void.

The EU was the first great accomplishment for the secular globalists. We have lost our way, misguided by star power with the pretence of progress.

The stars are now aligning for a totalitarian new world order.

A new Enlightenment is needed, or perhaps a Second Coming, and another Star of Bethlehem?

# Pfizer shot targets bone marrow

**PFIZER'S covid-19 'vaccine' shots target bone marrow and interfere with the body's ability to produce blood cells, research has shown.**

In a recent article, Dr William Makis highlighted three science papers about mRNA 'vaccines' which are cause for great concern. The three papers are:

After we are born, production of blood cells starts in the bone marrow. Bone marrow makes more than 220 billion new blood cells every day.

Haematopoiesis is the medical term used to describe the process by which our blood cells are formed, develop and mature into their final 'adult' types. The process begins with a haematopoietic stem cell (HSC), which then goes through a series of steps to arrive at the final product – a mature blood cell. A mature blood cell would be a red blood cell, a white blood cell such as a lymphocyte, or some other type of blood cell.

Lymphoblast cells are immature white blood cells that develop into healthy immune cells called lymphocytes. In leukaemia patients, for example, lymphoblasts don't mature. Instead, they multiply rapidly in the bone marrow, and interfere with blood-cell production.

In a 2020 *Nature Biomedical Engineering* study, researchers used a type of genetic therapy, known as RNA interference, and nanoparticles modified in such a way that they would accumulate in the cells found

in the bone marrow, rather than in the liver. These particles could be tailored to help treat heart disease or to boost the yield of stem cells in patients who need stem-cell transplants, *Penn Engineering Today* wrote.

RNA interference is a gene therapy that could potentially be used to treat a variety of diseases by delivering short strands of RNA that block specific genes from being turned on in a cell. Using this gene therapy technique with specialised nanoparticles, researchers from Penn Engineering and the Massachusetts Institute of Technology developed a way to turn off specific genes in cells of bone marrow.

"RNA nanoparticles hold promise for

many diseases, ranging from covid-19 vaccines to drugs that can permanently repair diseased genes," said Daniel Anderson, one of the authors of the study. "We believe that engineering nanoparticles to deliver RNA to different types of cells and organs in the body is key to reaching the broadest potential of genetic therapy."

"If we could develop technologies that could control cellular activity in bone marrow... it could be transformative for disease applications," said Michael Mitchell, one of the study's lead authors. The 2020 study was funded in part by the National Institutes of Health and the European Union's Horizon 2020 research and innovation program, among others.

In a paper published last week, Italian researchers treated lymphoblast cells isolated from the bone marrow of a 53-year-old chronic leukaemia patient with Pfizer's mRNA covid injection, at increasing concentrations. As the dosage of Pfizer's injection increased, the growth of stem cells was inhibited.

The study's authors concluded there was a 'need of great attention on possible alteration of hematopoietic parameters following SARS-CoV-2 infection and/or covid-19 vaccination.'

It was observed that the spike protein generated by the vaccination might have dramatic effects on, and alter, our bodies' ability to produce mature blood cells.

Dr Makis summarised the key points from Study 1 as follows:

- Pfizer's covid-19 mRNA injection accumulates in the bone marrow and can inhibit the growth and suppress the differentiation of bone-marrow stem cells.
- Pfizer's spike protein can increase the expression of pro-inflammatory genes.
- Spike protein production in bone-marrow stem cells increases dramatically with increasing mRNA dose.

In a National Institutes of Health-funded study published in July, the authors injected lipid nanoparticles containing mRNA and delivered them to bone-marrow stem cells where they conducted gene editing and 'bone marrow transplantation'.

The researchers developed two payloads: one that edited a mutation for sickle cell disease, and another that selectively killed haematopoietic stem cells (HSCs).

# Keep your landline telephones

## Campaigner Tanja Rebel is interviewed by Richard House

**Richard House [RH]:** What are the current known plans for landlines in the UK?

**Tanja Rebel [TR]:** Telecom companies are planning to pull the plug on essential landlines, aiming to phase them out by 2025. Analogue copper landlines will be replaced by less regulated, less reliable, less secure and more expensive wireless phones, or so-called Voice-Over-Internet-Protocol (VOIP). They lack a

sensible plan to keep people safely and reliably connected. British Telecom has already been moving customers from landlines to internet connections, though they've temporarily postponed the roll-out after escalating complaints from concerned customers who don't want to be forced onto the internet, rightly pointing out that a power cut will disable the VOIP connection.

**RH: Who's going to be worse affected by this? And is this part of the march of an unaccountable, inhuman technocracy?**

**TR:** Worst affected will be people with electro-hypersensitivity and other vulnerable groups, such as the elderly, who aren't tech-savvy, and for whom landlines are a lifeline. But we'll all be affected, especially those not wanting a mobile phone – for health,

environmental, security and privacy reasons – and who feel they're being forced into a 'Brave New Normal'.

The march into an unaccountable inhuman(e) technocracy is not inevitable. Once enough people realise what's happening, they'll ditch their 'smart' mirrors and demand copper, analogue, wired connections. Not fibre, notice – which is the precursor of 5G. Wherever fibre is installed, 5G masts follow. With a critical mass of refusers, government and telecom companies will have to listen, as it'll get ever harder for them to deny that copper analogue connections are safer, more reliable and don't pose a threat to public health or ecology.

**RH: What are the interests driving this?**

**TR:** Good question! The drive's

two-fold: fibre and wireless communication are a huge money-maker. People's drive for ever-more connectivity is fuelling the hunger for ever-more wireless gadgets. Fibre is also a way of getting faster speeds – read: unhealthily high frequencies – into the homes. The other motivation is control for the powers-that-be. Once landlines have gone, communication between people can be easily manipulated or stopped by turning off the electricity. Job done! Those with a mobile might still be able to use these, but masts can be temporarily disabled. Where will they be then? Not to mention that our smart mirrors are excellent surveillance tools.

**RH: What can people do to halt this outrage?**

**TR:** Most importantly, we must

ditch our smart devices – for the sake of our health, the environment, privacy and security, and demand a copper analogue landline. If you already have one, demand to keep it.

# Government must benefit us

Somers also wrote in the pamphlet: 'Whosoever, either ruler, or subject, by force goes about to invade the rights of either prince, or people, and lays the foundation for overturning the constitution, and frame of any just government, he is guilty of the greatest crime.'

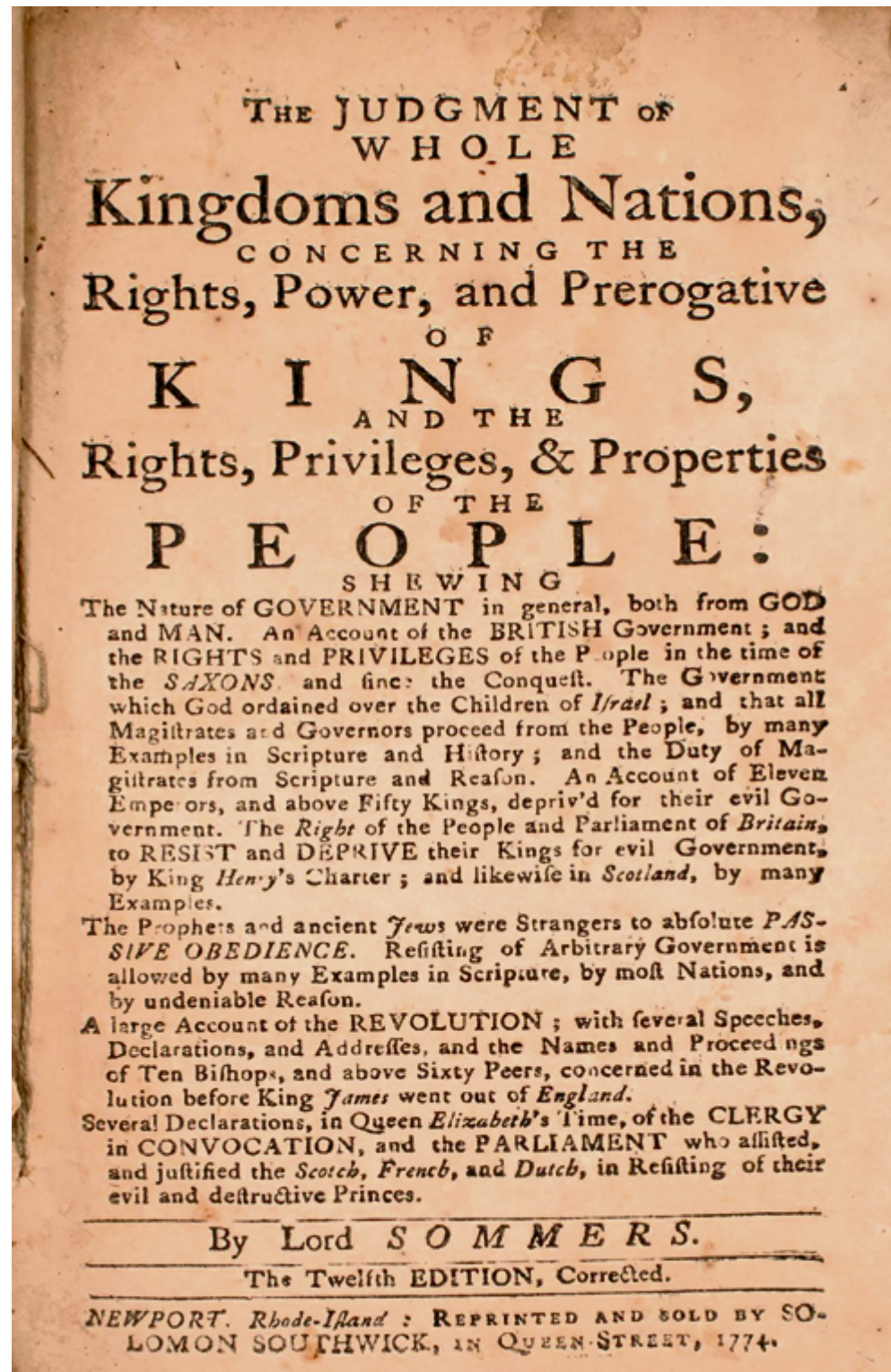
The pamphlet is a tour de force, so much so that its printer declares on its opening page that it 'is to be kept in all families, that their children's children may know the birth-right, liberty and property belonging to an Englishman.'

The U.S. Constitution is very much modelled upon the pamphlet. And herein lies the pamphlet's deep value: it is the expert upon which we can rely when we wish to more fully understand our own constitution and the Glorious Revolution.

To paraphrase, the pamphlet concludes that government is to benefit us and if we allow otherwise we are nuts!

Somers says: 'The whole Power of the King of England is to do good and not to do hurt; nor can he do anything as a King but what he can legally do.'

He was referencing the 1615 Case of Proclamations, being a lawyer after all, and



stating that which was well understood at the time: that we are all equal under the law and in elevating one amongst us to the position of king, we are simply electing the king as our first amongst equals.

Somers continues that the people could not give power to the king that they did not already have themselves. And he adds that the people have the God-given right to choose if they wanted a king or not.

So the true Great Reset was that which acknowledged that it is only ever the people who come together and form government, under contract for the benefit of those same people.

And so we come to our Bill of Rights, the

contract to govern.

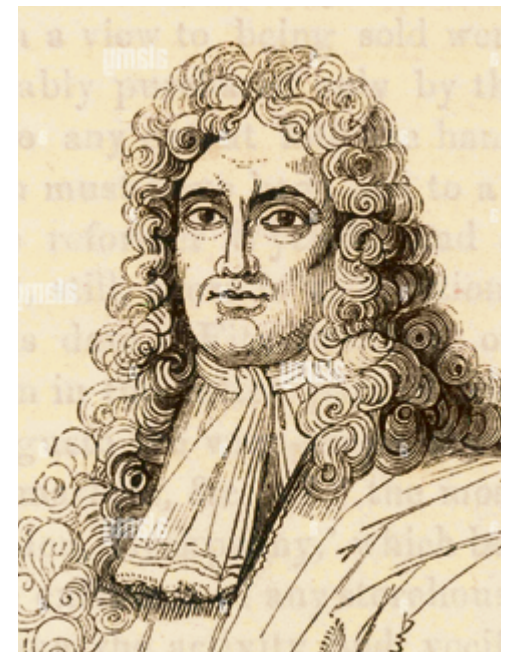
The Bill of Rights asserts the supremacy of the people over their king and by implication, government.

# NLP - focusing on the positives

## Part 2 of an interview with NLP expert David Molden

**Richard House [RH]:** Before going into how neuro-linguistic programming (NLP) can be used beneficently, tell us about its deployment for nefarious purposes during the covid madness.

The originators of NLP, Richard Bandler and John Grinder, modelled the highly effective techniques of hypnotherapist Milton H. Erickson. They learned how to communicate with the unconscious – a central feature of NLP. The conscious mind has to work hard to absorb, retain and process detailed information, whilst our unconscious easily processes generalisations.

To speak directly to the unconscious, you use ‘artfully vague language’; so rather than say ‘there are over 10,000 infections’, you say ‘infections are at a dangerously critical level’. Adding a red backdrop, you have a recipe for planting fear into the unconscious mind. When we began to see the C-19 infection charts 24/7, few will now recall the actual numbers quoted, but the unconscious would easily process and retain the colour red, and the rising chart-lines. Red for danger - we all know this.

Marketing has long used NLP to create strong associations to products. The yellow rounded ‘m’ is deep in the unconscious of fast food lovers, a happy smiling clown associated with unhealthy food – but hey, that doesn’t matter when you’re

hungry. Similarly, the three images on the PM’s C-19 lectern - reinforcing masks, six feet safe, wash hands - were always blue, the colour of masks. There’s association right there! Notice now how weather charts have turned to red, implanting fear of the so-called climate crisis. Simply associate your artfully vague message with a colour and an image.

**RH: And fear generation is at the heart of all this?**

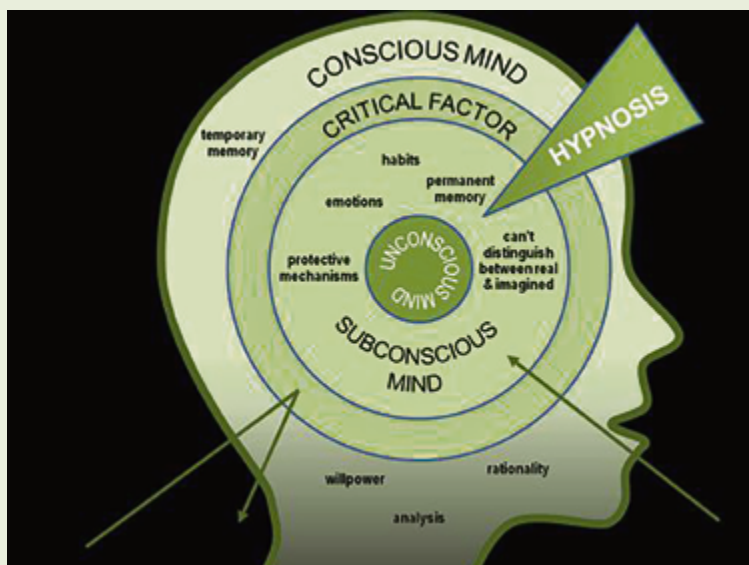
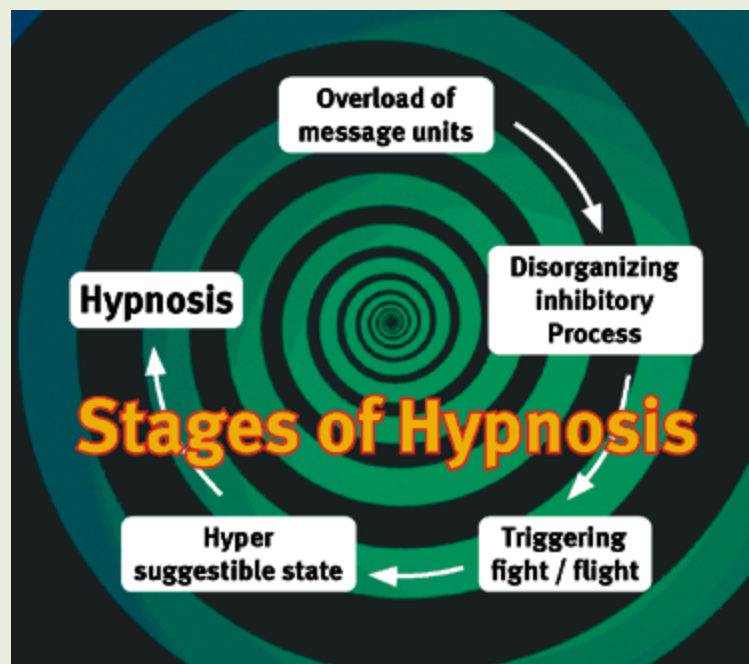
**DM:** Yes – fear is disabling. It removes control from your conscious mind, the one that can reason and articulate facts, and hands it to your unconscious, which wants to keep you safe. But confusion is another element being used – there are many ways to put a person under hypnosis using confusion. When the conscious mind is confused, the unconscious takes over and, hey presto, you’re under the spell!

**RH: So these dynamics must feed into people’s decision-making process.**

**DM:** To make decisions, we each have an unconscious strategy running that we use to decide how to proceed – whether it’s deciding what colour to paint the kitchen, or how to deal with illness. Imagine a continuum, a spectrum, with Internal Reference at one end and External Reference at the other. Many will rely on external references in order to make decisions – the experts, the media, friends, and what they see others doing. These are the people who went along 100 per cent with everything they were told to do, and are ideal candidates for hypnosis.

At the other end of the continuum, people rely more on their own internal reference in order to make a decision. They’re very likely to be awake, critical thinkers and less prone to being hypnotised. Many or most people will sit somewhere along this continuum. They’ll listen to others, but have a degree of internal rationale.

When combined with fear, though, the external reference becomes stronger for many



people, perhaps even overcoming any attempt to rationalise.

**RH: And how does repetition come into the picture?**

**DM:** The more an artfully vague message of impending doom is broadcast, over time and in various places, the more your unconscious will keep you in a state of perpetual fear. So the shops with mask posters and social distancing stickers on the floor all contribute to reinforcing the hypnotic fear-state.

Readers may be interested to know that the UK government have all attended NLP training in the past 20 years or so, and for my sins, I was one of the trainers. Little did I know then how they were intending to use it.

**RH: Tell us a bit about the training?**

**DM:** A common theme in NLP training is to help people release themselves from fear and rise above it, in order to explore their full potential. When you’re truly fearless, you can be and do anything you desire – as long as you’re

willing to put in the effort. As Tony Robbins has it, ‘there is part of you that will always be fearful; just don’t let it be in charge’.

**RH: Phew – understanding all this is great for helping to neutralise the malign impact of these techniques of control, but there’s more to say about NLP’s positives!**

## Freedom campaigner Debbie Hicks interviewed by Richard House

**RH:** Debbie, in issue 23 ([tinyurl.com/ykjyfmjp](https://tinyurl.com/ykjyfmjp)) in 'Keep cash to protect our freedom', you spoke about your first cash campaign – how did it go?

**Debbie Hicks DH:** The objective of the campaign was to 'mobilise people' to take direct actions to promote cash and educate the public on the dangers of programmable money. At first I struggled to get the message out and get support (many were understandably still focusing on lockdown and vaxes), but now I'm pleased to see groups taking local action all over the country. It's been a great success.

**RH:** Great work! So what's different about your new campaign?

**DH:** This campaign is called 'Keep Cash Local: The £5 a week cash pledge'. The campaign moves on from building activism and awareness, to giving everyone who agrees a way to commit to using cash, while pledging to spend it in a local, smaller business. Therefore, this not only helps people become active in promoting cash, but it also supports our local high street and struggling small businesses.

**RH:** Simple but brilliant! So there's an evolution here from advocating for a general principle (i.e., keeping cash) to more targeted help for struggling local businesses shafted by the covid-fuelled shift to online retailing. What's involved in making the pledge?

**DH:** People can participate online by adding their name to the pledge, or by using the '£5 Keep Cash Local' emblem, or they can take a small leaflet and a sticker or badge from us that shows they're participating. The double-sided leaflet will also be for shops and businesses that participate to display in their windows.

**RH:** So will you need people to 'sell' the idea shop-to-shop in their local area, offering shop-keepers the display leaflet? And could the pressure of a high-profile Keep Cash Local campaign impact on the trend towards businesses going card-only?

**DH:** Yes! It's another tool activists can use on outreach to give to shops and the passing public. If the campaign gets recognition and is promoted, it will help those rising cash circulation figures go even higher, and make a cashless society less likely to work.

# False flags and crimes of governments 1945-2020

**1945 Operation Paperclip**  
The German scientists, technicians and engineers had made brilliant and groundbreaking advances in many fields in the lead up to and during the war, and the victors didn't have a moral problem with the Nazi weapons of destruction... the only problem was that the brilliant scientists were on the wrong side. The U.S. got a sizeable portion of these Nazi scientists (around 1500) and smuggled them into NASA, the CIA and Hollywood, where some of them such as Werner von Braun went on to make a name for themselves. Thus, the U.S. willingly allowed its military and intelligence agencies to be infected with Nazi ideology, which continues to this day.

**1946 Operation Gladio**  
The two-decade operation used CIA-created 'stay behind' networks as part of a 'Strategy of Tension' that unleashed a multitude of terrorist attacks from the late 1960s to the early 1980s. The attacks were blamed on marxists and other left-wing political opponents in order to discredit communism. The operation involved multiple bombings that killed hundreds of innocent people, including children. The most notable attack was the August 2, 1980 bombing of the Bologna train station, which killed 85 people.

**1953 Operation Ajax**  
In 1953, the CIA launched Operation Ajax in order to overthrow Iran's democratically elected leader, Mohammed Mossadegh, and replace him with the Shah, a ruthless dictator. The United States sought to depose Iran's nationalized Anglo-Persian oil company and install 5 U.S. oil companies to take over the nation's oil fields. In order to do so, they staged a false flag operation that utilized propaganda and complex political manoeuvres in order to create public revolt that eventually led to the United States and Britain's M6 military intelligence re-installing the Shah in order to throttle Iran's oil supplies and transform the nation into a puppet regime of the United States.

**1954 Lavon Affair**  
Israel admits that an Israeli terrorist cell operating in Egypt planted bombs in several buildings, including U.S. diplomatic facilities, then left behind 'evidence' implicating eight Arabs as the culprits. One of the bombs detonated prematurely, which caused one of the bombers to be captured. A public trial exposed the Israeli spy ring and the covert operation. The operatives were convicted and two of them executed. Israeli Defense Minister, Pinhas Lavon was forced to step down because of the scandal. However, the more far-reaching consequences of the Lavon Affair demonstrate once again how governments use false flags to achieve certain objectives that might not have been possible otherwise.

**1955-1956 Stolen Documents Describe FBI Surveillance Activities**  
COINTELPRO  
A program run by the FBI under Hoover which started in 1956. COINTELPRO was a series of undercover operations that targeted people and groups the US Government deemed were a problem, such as the communist party, other far left groups, civil rights groups, far right groups (e.g. the KKK) and individual activists such as Martin Luther King. The scope of COINTELPRO was broad: it involved monitoring, surveilling, infiltrating, discrediting and disrupting. Although then Attorney General Robert Kennedy authorised some spying, the FBI was given an inch and took a mile (much like today's spy agencies), clearly overstepping the bounds of legality. It became a way for the government to intimidate and stifle dissidents.

**1955-1956 Operation Mockingbird**  
Operation Mockingbird was a CIA project to infiltrate and covertly control the media. It began in the 1950s under then CIA director Allen Dulles. The declassified files show how the CIA infiltrated the mainstream media and had its pieces inserted into TV, newspapers and journals everywhere as "news" when they were nothing more than lies and propaganda. Richard Salant, former President of CBS News, once said that "our job is to give people not what they want, but what we decide they ought to have." Mockingbird was famously exposed in the 1975 Church Committee hearings. Nothing much has changed today. Journalists worldwide are still on the payroll, and some were brave enough to talk about it, such as the late Udo Ulfkotte.

**1962 Operation Northwoods**  
The 1962 declassified US Joint Chiefs of Staff Memo was entitled "Operation Northwoods - Justification for US Military Intervention in Cuba." In its own words, the document states that a "series of well coordinated incidents will be planned to take place in and around Guantanamo to give genuine appearance of being done by hostile Cuban forces." Luckily JFK had the wisdom to reject the plan; by 1962 he had discerned the insidious influence of the Military Intelligence Complex upon his presidency.

**1964 Gulf of Tonkin**  
The most notorious declassified false flag in American history. It resulted in the deaths of millions of people. Declassified documents reveal the North Vietnamese did not attack the United States on August 4, 1964. In fact, the CIA, through its South Vietnamese proxy, invaded North Vietnam and the standoff in the Gulf of Tonkin was a result of those illegal covert raids conducted under OPLAN 34A. President Lyndon Johnson's Secretary of State, Robert McNamara, led to a joint session of the Senate Foreign Relations and Armed Services committees about the role played by the Navy in the phantom attacks. Declassified documents also reveal a number of senators knew the incident in the Gulf of Tonkin was a false flag.

**2001 9/11**  
The false flag which dominates the modern era. Without getting bogged down in the purposely convoluted complexity and many plots and subplots, the results of this operation are clear: the invasion and destruction of Iraq, despite no evidence at all of any connection, and the heightened security and removal of civil liberties domestically that followed and under which we now all live every day. Those who still believe the official story despite the facts, litany of media spin and government cover-ups have simply not watched James Corbett's '9/11: A Conspiracy Theory'.

**2001 Fake Anthrax Attacks**  
Although the FBI now admits that the 2001 anthrax attacks were carried out by one or more U.S. government scientists, a senior FBI official says that the FBI was actually told to blame the Anthrax attacks on Al Qaeda by White House officials (remember what the anthrax letters looked like). Government officials also confirm that the White House tried to link the anthrax to Iraq to support the false 9/11 justification for 'regime change' in that country.

**2013 Syria Fake Chemical Attacks**  
In 2013, to try and justify launching bombing attacks in support of the rebel alliance fighting with Al-Nusra and Al-Qaeda against President Assad of Syria, the media and especially the BBC faked a hospital supposedly receiving children with injuries from gas attacks. Videos exposing the hoax circulated widely on the internet and a massive public backlash resulted in Prime Minister David Cameron being defeated in the House of Commons when asking for air strikes on August 29th. The regime waited a year and did it anyway via supporting U.S. strikes supposedly on terrorists in Iraq and Syria. Russian military involvement saved Syria on that occasion.

**2020 Operation Lockstep: Covid-19**  
The insane response of governments to the as-yet-to-be-wholly-isolated-from-an-infected-person pathogen is responsible for yet further massive loss of liberties and the ability to work and provide for one's family across the world. The latest in a long line of establishment scams, deceptions and terror perpetrated on an unsuspecting public through the power of the media machine and the lockstepping of all world governments.

## Social Credit Scoring

Although you might pay electronically now with your card or phone, you currently have full control over what, where, when and how you spend your money, and you also have the option of going to a branch or ATM and withdrawing cash which is always fully private and flexible.

**PRIVACY:**  
CBDCs are blockchain technology - a digital ledger of every single transaction, recorded permanently. Anyone with access, at any time in the future, will be able to look at everything you have bought and sold, every bill and tax you've paid or not, and use anything they find against you.

**FREEDOM:**  
"Smart" money means banks will be able to limit where and when you can spend, as well as what you can buy. It could be linked to a carbon allowance, so you only get so much fuel or meat each month. Your wallet could be frozen, or limited to how far from your registered address you can use it.

**SAVINGS:**  
Money with an expiry date means you will never be able to save and create financial stability for yourself or your family. Everyone will be living hand-to-mouth and unable to plan financially.

### ALWAYS USE CASH

Use bank branches/ATMs to withdraw cash for the day/week, and then spend that everywhere. Keep your card/phone in your pocket.  
Paying with cash all the time keeps the infrastructure and jobs in place to service it - bank cashiers, ATMs, ATM build and maintenance, cash tills and transport, security guards, and everyone involved in producing, transporting and dealing with cash. Once this is gone it won't be coming back, so keep it alive and give them no excuse to go "all-digital".  
They will never say: "It's to control everyone's finances so we can make you do what we say." They will say: "It's because everyone uses apps and cards anyway, and this is the logical next step."  
Ditch the apps, and use your cards to withdraw cash to spend everywhere, and where they don't take cash, don't spend.

# New kids on the bloc

## More countries joining BRICS alliance

**BRICS emerging alliance - Brazil, Russia, India, China, and South Africa - recently held an important meeting in Johannesburg to cement their growing global economic influence.**

The summit also called for a 'comprehensive reform of the UN, including the Security Council'. The meeting in August was the 15th annual BRICS summit.

During the two-day meeting, Russian leader Vladimir Putin said: "Over the past ten years, mutual investment between the BRICS member states has increased by six times. Their total investments in the world economy have doubled, while cumulative exports account for 20% of the global total."

Before the important summit, Chinese President, Xi Jinping, stated the talks would "strengthen cohesion and cooperation among developing countries to an even higher level".

At a press conference after intensive BRICS meetings, South African President, Cyril Ramaphosa, outlined the key outcomes: "These include the need for beneficial economic growth, sustainable development, and reform of multilateral systems. As the five BRICS countries, we have reached agreement on the guiding principles, standards, criteria, and procedures of the BRICS expansion process, which has been under discussion for quite a while. We have consensus on the first phase of this expansion process, and further phases will follow."

From January 1, 2024, President Ramaphosa reported that oil-rich Saudi Arabia, United Arab Emirates as well as Argentina, Egypt, Ethiopia, and Iran will become full members of the expanding BRICS coalition. According to Al Jazeera, there are another 40 countries hoping to join the new bloc.

According to German online

platform Statista: 'The G7, consisting of the United States, Canada, the United Kingdom, Germany, France, Italy, and Japan, has held sway over global economic governance and decision-making. However, as the BRICS nations experienced rapid economic growth and development, their collective influence and ambition began to grow.'

News site, Zerohedge, reported: 'China's spectacular economic ascent in particular has reshaped global trade, investment, and supply chains. The country's manufacturing prowess, massive consumer market and innovation-driven growth have propelled it to the forefront of the global economy.'

'While India is still a couple of steps behind, its massive population and bustling tech industry position it well to become the bloc's second economic superpower. Meanwhile Russia, Brazil and South Africa have fallen short of expectations, with their share of global GDP (at purchasing power parity) actually declining over the past two decades.'

Despite the emerging alliances and fanfare around the meeting in South Africa, there are natural suspicions within BRICS nations of hidden intentions and takeovers.

Felix Richter from Statista stated: "While the leaders of Brazil, Russia, India, China, and South Africa tried to demonstrate unity

at the 15th BRICS summit in Johannesburg, the group is not as tightly knit as this week's event and the lofty rhetoric employed afterwards would suggest.

"According to the Pew Research Center's latest Global Attitudes Survey, China is seen quite critically in some fellow BRICS countries, with Indians in particular having a very critical view of their powerful neighbour. "And 50% of Indian respondents claimed to have a very unfavourable opinion of China, with another 17% viewing China somewhat unfavourably. Relations between the two countries have been worsening for several years over tensions along their ill-defined 2,100-mile

border in the Himalayan region.

"And 48% of Indians claimed to have no confidence at all in Xi Jinping to do the right thing regarding world affairs, while 58% said that they wouldn't take Indian interests into account when making international policy decisions.

"Brazilians showed similar levels of suspicion with respect to cooperation with China. While 50% of Brazilian respondents said that China wouldn't take their country's interest into account, 67% expressed little to no confidence in Xi Jinping to do the right thing at the global political stage. That translates to 48% of Brazilian respondents having a very or somewhat negative opinion of China, up from just 27% in 2019."

According to the International Monetary Fund (IMF), the bloc will collectively account for 32.1% of global GDP this year. That's up from just 16.9% in 1995 and more than the G7's share of 29.9%.

The Financial Times reported: 'Excluding the EU - which is classified as a G7 "non-enumerated" member - the group of advanced democracies accounts for just 9.8% of the world's population and 29.8% of global gross domestic product, calculated by purchasing power parity.

'The new BRICS group, by contrast, will account for 47% of the world's population and 37% of its GDP based on purchasing power parity.' The FT also said that: 'China will push the BRICS bloc of emerging markets to become a full-scale rival to the G7.'

The customary dominance of G7 nations as world powers is no more, and the changing of the guard is clearly imminent. The geopolitical and economic landscape has shifted, and BRICS is stepping up as an economic heavyweight now as opposed to the current feeble, woke G7 nations.

# '5G can activate vaccine payloads'

## Study shows wireless signals could trigger 'kill switch' in human body

**AN official study has found that mobile phone signals can be used to release a biological or chemical payload - which can be introduced into the body via an mRNA vaccine.**

The paper from sciencedirect.com shows how a mobile phone can send a signal to activate a low-voltage current that interacts with graphene oxide (GO) molecules, enabling efficient delivery of drug payloads.

According to a report from naturalnews.com: 'Due to its extremely large surface area and complex structural composition, graphene oxide is proving to be the perfect molecule for delivering biological or medical agents into the body.'

An article by Dr Joseph Mercola in the journal, *Children's Health Defense*, shows that signals from 5G cells cause measurable biological and chemical changes in the body. From his article:

1. 5G relies primarily on the bandwidth of the millimetre wave, known to cause a painful burning sensation. It's also been linked to eye and heart problems, suppressed immune function, genetic damage and fertility problems.
2. The Federal Communications Commission (FCC) admits no 5G safety studies have been conducted or funded by the agency or telecom industry, and that none are planned.
3. The FCC has been captured by the telecom industry, which in turn has perfected the disinformation strategies employed by the tobacco industry before it.

Additionally, a study led by Martin Pall, Ph.D., professor emeritus of biochemistry and basic medicine at Washington State University, shows that microwave radiation from mobile devices and Wi-Fi routers can cause voltage changes in human cells.

This leads to the creation of 'voltage gated calcium channels' (VGCCs) in the outer membrane of cells. This membrane determines what moves in and out of the cell.

This means that radiation from cell phones - and radiation from 5G cell towers - can actually cause voltage changes in the

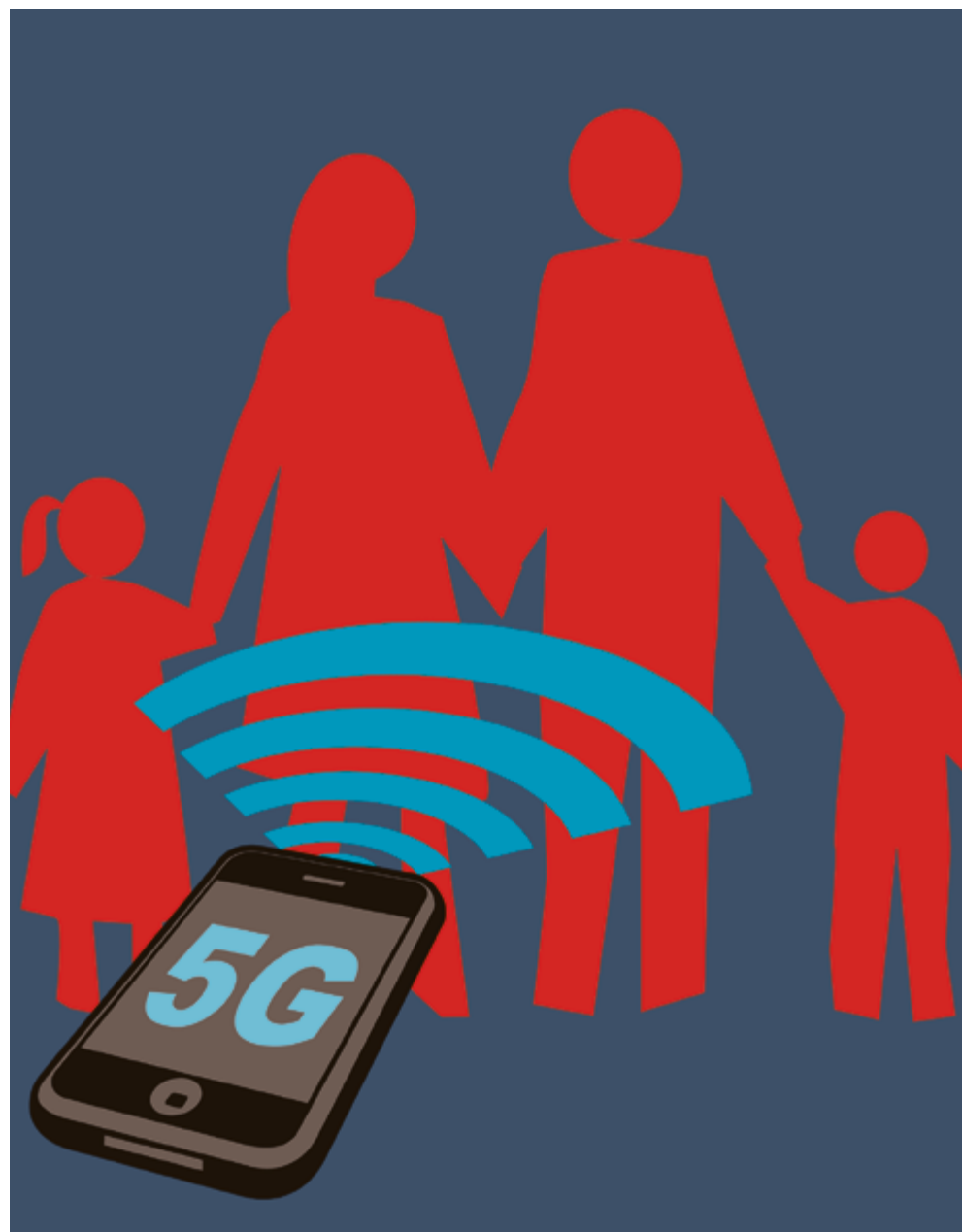

human body, and that these voltage changes have very real biochemical effects, some of which can be dangerous to human health.

Reuters has reported that French regulators warned Apple to stop selling iPhone 12 phones because the devices produce too much radiation. Apple's smartphone exceeded legally allowed radiation limits. This phone has been sold since 2020.

In summary, 5G signals can be used to generate low voltages within the human body, causing graphene oxide molecules to release a predetermined payload within the body. Upon application of external stimuli, many materials are able to release drugs. However, most of them need sophisticated instruments except electrical

stimulation. Electro-stimulated drug delivery has attracted attention due to the low expense, painless, and portability of the control equipment.

The conclusion from the sciencedirect.com paper adds: 'Our lab-made remote-controlled device efficiently released the anticancer drug. The releasing process can easily be switched on and off with a mobile phone by changing the bias voltage.'

In the study, the payload consisted of aspirin and a common cancer drug. However, the payload can be almost anything small enough, including hydrophilic and hydrophobic molecules.

This means that powerful chemical weapons - theoretically including

neurotoxins lethal at nanogram-level exposure - could be loaded into graphene oxide molecules.

In theory, such weapons could reach people through vaccines and food sources. Once a small amount of the payload enters the body, some degree of neurological damage may be caused to the victim, but actual payload transmission will not occur until an appropriate 5G signal is sent to the vaccinated population using a 'release frequency'.

This technology could be used as a 'kill switch' to terminate whatever portion of the population was previously inoculated with a lethal payload.

The conclusions of the sciencedirect.com paper included:

1. Graphene oxide can carry chemical or biological payloads.
2. Graphene oxide carrying payloads can be introduced into the body through vaccines or swabs.
3. The release of those payloads can be controlled by external cell tower signals which cause specific voltage changes in human cells.
4. Graphene oxide payloads can include 'kill switch' payloads such as nerve agents or infectious agents.
5. The 5G tower system can therefore function as a chemical weapons payload release infrastructure system to achieve a 'mass kill' of populations which were previously inoculated.

Given that the world's Western governments are currently clearly trying to cull their own populations, this conclusion should worry anyone who wants to survive the 'sustainable' agenda.

**I FIRST wrote about mass vaccination over two decades ago and I wear the ‘anti-vaxxer’ label with pride.**

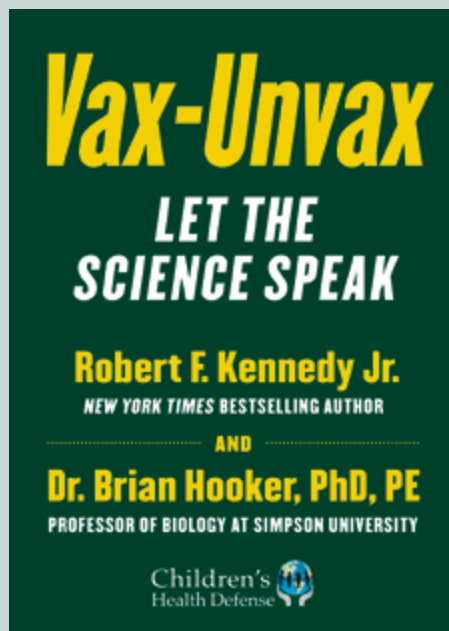
I’ve long believed that the genuine, uncaptured science will eventually reveal beyond any equivocation that living a non-vaccine life is a healthier option by far.

Last year I transcribed two excellent interviews on the question of vaxxed vs unvaxxed health outcomes with vaccine researchers Dr Brian Hooker and Neil Z Miller, and discovered a great 14-minute film on the issue.

I’m thrilled that a new book has just come out, authored by U.S. presidential candidate, Robert F. Kennedy Jr and Brian Hooker – *Vax vs Unvax* – which promises to hammer a massive nail into the coffin of Big Pharma’s mass vaccination trance-induction that has dominated



mainstream medicine for far too long.

As early as 2020, there already existed a number of major peer-reviewed research studies showing massively better health outcomes for the unvaccinated when compared with those who had received the normal vaccine schedules.

These studies merely confirmed what principled and informed ‘anti-vaxxers’ had been saying for years. So it’s very exciting that RFK Jr and Hooker have now taken the science to a quite new level, with unequivocal scientific evidence on the superiority of a vaccine-free lifestyle. Not that we should be holding our

breath for anything to change: in 2009, psychology professor Irving Kirsch published a ground-breaking book which showed beyond doubt that, except in a very small range of severe cases, anti-depressant medication is no more effective than placebo.

In any conceivable rational, evidence-based world, this book’s revolutionary findings should have brought an end to the medical use and prescription of anti-depressants – but did they?

Emphatically not, with all the evidence showing that anti-depressant usage is actually soaring. So much for much-vaunted evidence-based medicine.

What this illustrates all too starkly, of course, is that Big Pharma has the medical world by the throat, and has mesmerised medical consumers (i.e., us) into unthinkingly believing that a psycho-active pill is the effective treatment for ‘depression’ – even when the scientific evidence conclusively shows that it isn’t.

This cautionary tale, then, should leave us under no illusion that the publication of Kennedy and Hooker’s new book will of itself bring an end to global mass vaccination.

Rather, it is independent publications and word-of-mouth that will be vital in raising grass-roots awareness amongst medical consumers, and so helping to bring about this urgently needed health transformation.

I was thrilled when Hooker announced their new book, *Vax–Unvax*, in an exclusive interview in Jonathan Otto’s recent docu-series, *Disease in Reverse*.

In that interview, as well as giving chapter and verse on the scarcely believable corruption in the world of vaccine research, and the fraudulent suppression of inconvenient research findings, Hooker spoke of how “unvaccinated children have less ear infections, they have less pneumonia, have less developmental delays, have less asthma, have less gastrointestinal issues, have less ADD and ADHD, fewer neurological issues in general and their mortality rates are lower. And all of this information, the CDC and the Pharmaceutical Complex are trying to suppress.”

He describes how the book has bright, easy-to-read graphics “where someone could pick it up with a non-scientific background, read about the study [in question], and could see directly how vaccinated individuals do compared to unvaccinated”.

We could be on the verge of a momentous and decisive paradigm shift in medicine and healthy living. A post-pharma world is urgently beckoning.

# Not another scary variant!

The 'at-risk' category includes people over 65, older adult care home residents and immunosuppressed people. The article states that: 'The plan is to jab as many eligible people as possible by 31 October.'

The new variant is known as BA.2.86, but is also called Pirola,

which Wiktionary defines as 'penis'.

In addition to this mockery is their obvious attempt to sow seeds of confusion. For example, the Center for Disease Control (CDC) web page entitled, *Risk Assessment Summary for SARS CoV-2 Sublineage BA.2.86* states: 'BA.2.86 may be more capable of causing infection in people who have previously had covid-19 or who have received covid-19 vaccines.'

Note the use of the term 'may be more capable' - clearly, they have not yet proven their claim.

If there is 'limited information' on this variant, then how can they be so confident in the ability of

the vaccines to confer immunity? The answer is, of course, that they can't - even if vaccines were capable of conferring immunity, which they are not.

The scale of the fear-mongering is impressive, yet, according to the CDC web page, under the heading, *Scientific Understanding of BA.2.86 as of August 23, 2023*, the total number of reported cases is nine. 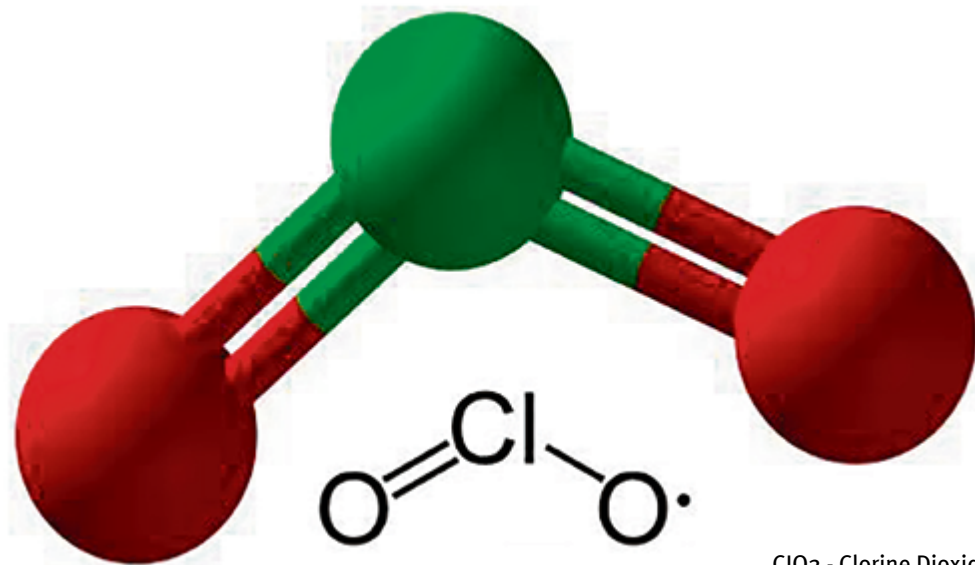
### CHLORINE DIOXIDE KILLS HARMFUL BACTERIA?

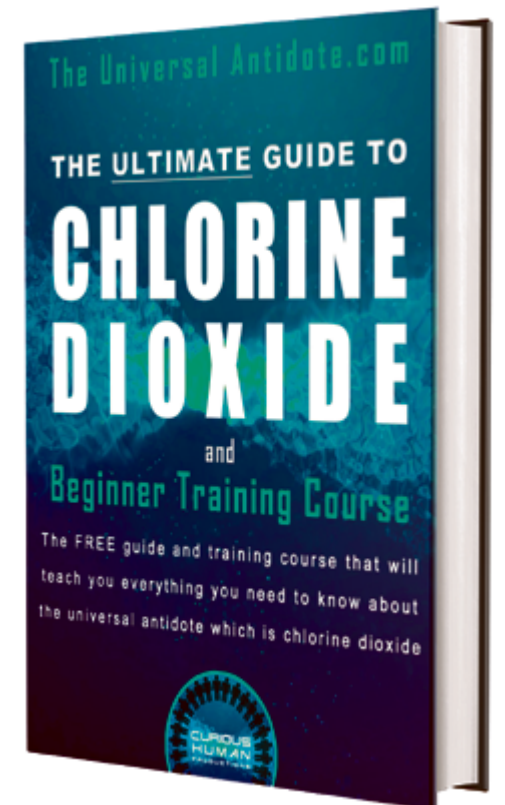

research about the compound. Studies have been done showing chlorine dioxide to be effective at killing coronaviruses too. The medical establishment is trying to suppress the sharing of any potential

Because most people have traditionally trusted authority and government, they believe the dangers that are faithfully reported by the mainstream media and come to two quite rational conclusions. First, that the world is clearly a dangerous place, and second, that we are only kept safe by being able to take cover under the protective wing of 'society'. Thank goodness for that!

But the idea of society, of course, is now nothing more than a cover for a universal system of globalist control. We are social creatures, and this collectivism simply abuses our natural tendency to trust and rely on our fellow tribe members.

The great thing about fear is that, used in the right (wrong) way, it can extinguish any risk of undesirable behaviours such as free thought and resistance. Now, a moderate dose of concentrated, acute fear stimulates release of the hormone adrenaline, which can help us to take extreme measures to resolve an immediate threat. It is potent, invigorating, and empowering. A warrior uses adrenaline to achieve great things. Chronic fear, however, really is the mind-killer. Living under a constant cloud of intangible threat does not stimulate adrenaline but cortisol, the stress hormone. The constant influence of cortisol is profoundly bad for our health. It suppresses our ability to think rationally and drives us down into a state of mild depression where the idea of taking any kind of radical, positive action becomes unthinkable.

That is precisely the ideal state in which slaves should be kept. A terrified slave is still able to continue with its mundane tasks, but unlikely ever to rise up against its owners. It is why Niccolò Machiavelli, the original life-coach of tyrants, wrote: 'It

is better to be feared than to be loved, if one cannot be both.'

In times gone by, the slaves' constant fear may have been of being flogged or having their food withheld. Today, it is not much different. So many of us fear being unable to put food on the table, as almost 40 per cent of UK households are living just one paycheck away from destitution.

What does constant fear do to a human being? It turns us into quivering cowards, which is exactly what the controllers rely on. Live under the illusion long enough and Stockholm Syndrome sets in, where the captive begins to experience feelings of compassion and even love for their captor.

And how the people have been groomed to relish in that feeling of being protected! Remember the muzzled hordes shuffling round the supermarkets with

their carefully wiped-down trolley handles and obediently following the arrows?

Look under the bed. There is no monster! So where is the fear? It's not anywhere out there, it's in here. It exists only in our own minds, and only when we allow ourselves to be spellbound by the evil ones. And the genius of their system of fear is that it is designed to keep us keeping ourselves imprisoned.

Gandhi put it well: *"There would be nothing to frighten you if you refused to be afraid."*

The fear trap is a virtual open prison. Long-term exposure to scary stories, this nightmare that never ends, creates invisible bars that prevent us from overstepping our allocated boundaries. We are our own prison guards, and some of us still revel in being awarded that duty!

What if we gave up the mass addiction to cowardice? Most people would be utterly lost with no idea of what to do. Like the character Brooks in *Shawshank Redemption*, who couldn't cope without the security of the bars and walls around him and chose what seemed an easier way out.

But you and I dare to dream!

What would it feel like... no, what WILL it feel like WHEN we stand? How will it feel to walk outside and meet other free men and women, warriors for truth and justice, to look them in the eye and know that all it took was for each of us, individually, to say 'No!' to fear and simply to stand up?

What's stopping us? The fear of being dragged and beaten by riot police? What if we gave up that fear too? Perhaps we would experience what the activist Malcolm X described, when he told a reporter who asked him if he got afraid: *"No, I don't worry. I tell you, I'm a man who believes that I died 20 years ago, and I live like a man who is dead already. I have no fear whatsoever of anybody or anything."*

To quote Gandhi once more: *"The enemy is fear. We think it is hate, but it is fear."*

There is nothing to fear but fear itself. We banish fear! And that of course means facing the deepest fear of all. In the immortal words of Marianne Williamson, which it is worth quoting in full:

*Our deepest fear is not that we are inadequate.*

*Our deepest fear is that we are powerful beyond measure.*

*It is our light not our darkness that most frightens us.*

*We ask ourselves, who am I to be brilliant, gorgeous, talented and fabulous?*

*Actually, who are you not to be?*

*You are a child of God.*

*Your playing small does not serve the world.*

*There's nothing enlightened about shrinking so that other people won't feel insecure around you.*

*We were born to make manifest the glory of God that is within us.*

*It's not just in some of us; it's in everyone.*

*And as we let our own light shine, we unconsciously give other people permission to do the same.*

*As we are liberated from our own fear, our presence automatically liberates others.*

**The time is now. Time for each and every one of us to stand, time to rise, and shine.**

**We own a coffee shop in Saffron Walden and are proud to stock your fantastic publication.**

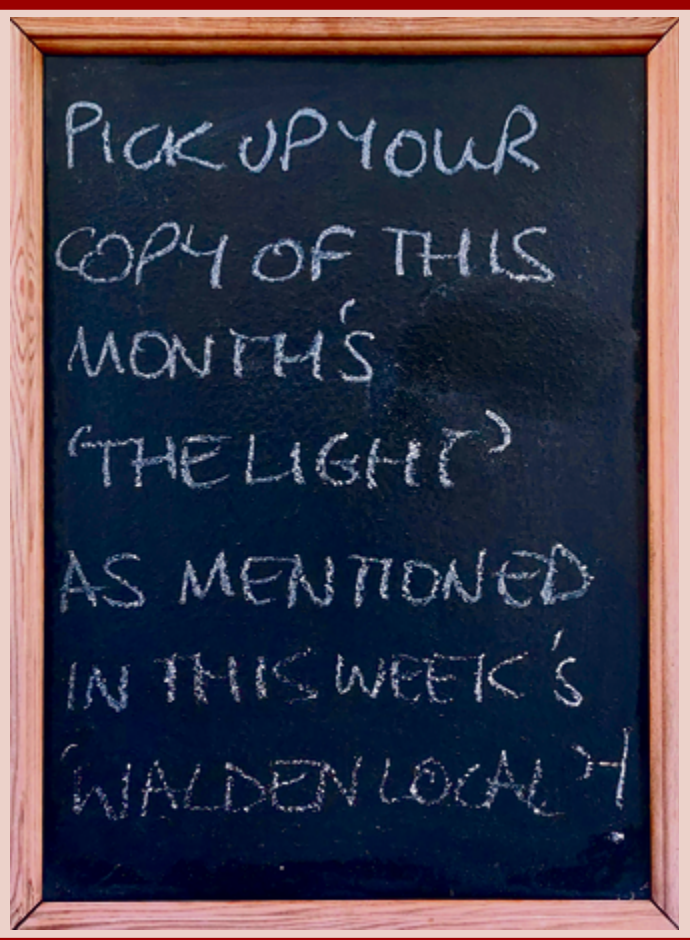
We are very much a lone voice in this town, so the past three and a half years have been extremely difficult to say the least. Knowing that there are people like you defending truth has been an enormous source of support.

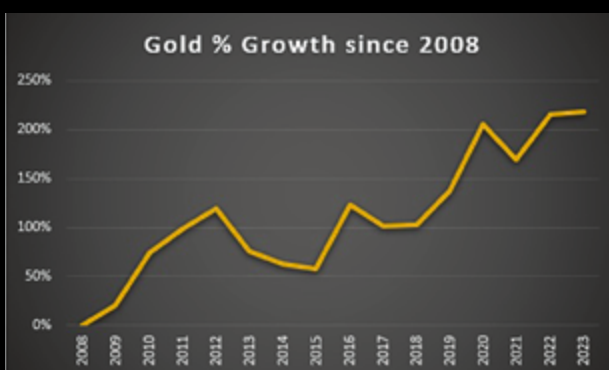
